## Banking and financial markets in Latin America in a time of crisis

## Leniency: the future for cartel enforcement in Latin America

During the last few years, some Latin American jurisdictions have created leniency regulations in order to improve cartel enforcement. Although increasing numbers of leniency cases have been filed in Latin America during recent years, in some countries, leniency has not yet emerged as the main tool for cartel detection in Latin America. How does leniency work in those countries and in non-Latin American jurisdictions? Which and how many leniency cases were filed during the last five years in Latin America? Are confidentiality issues and civil and criminal actions a deterrent for leniency? Which are the challenges for a multi-jurisdiction leniency process that includes Latin American countries? Is it a matter of time before leniency becomes the main tool for cartel enforcement in all of Latin America?
